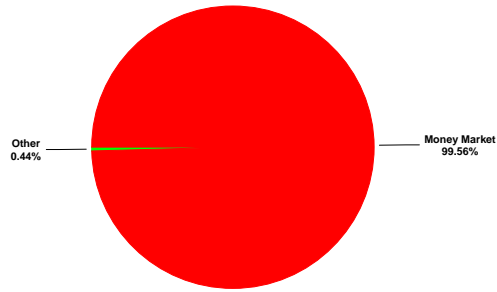

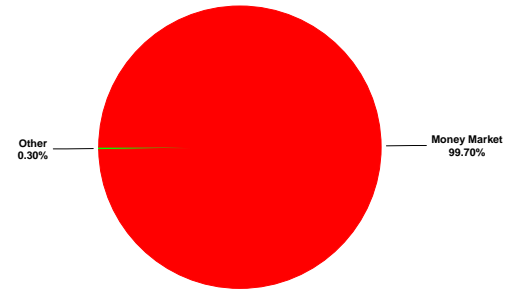

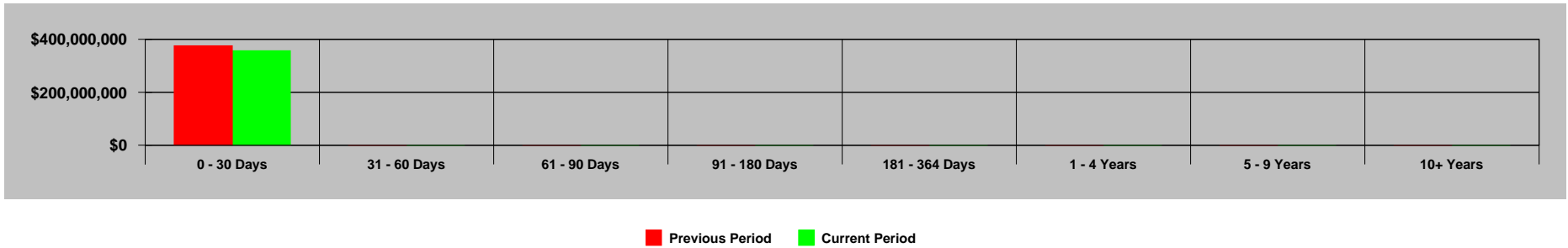
### Portfolio Composition - 03/31/13



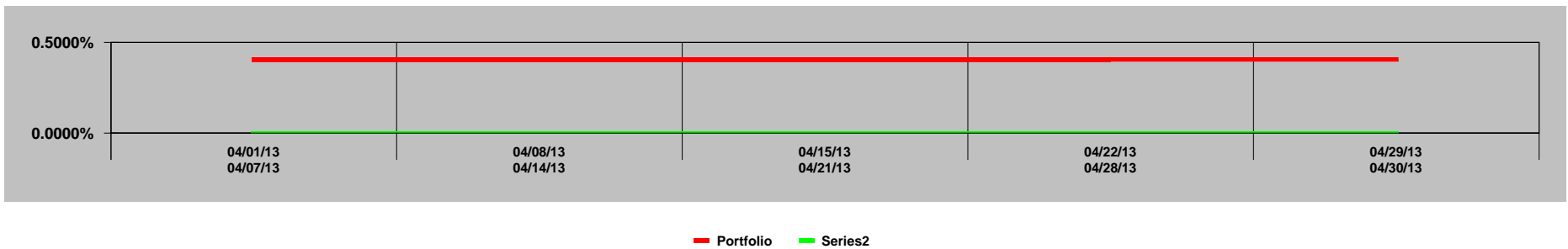
### Portfolio Composition - 04/30/13

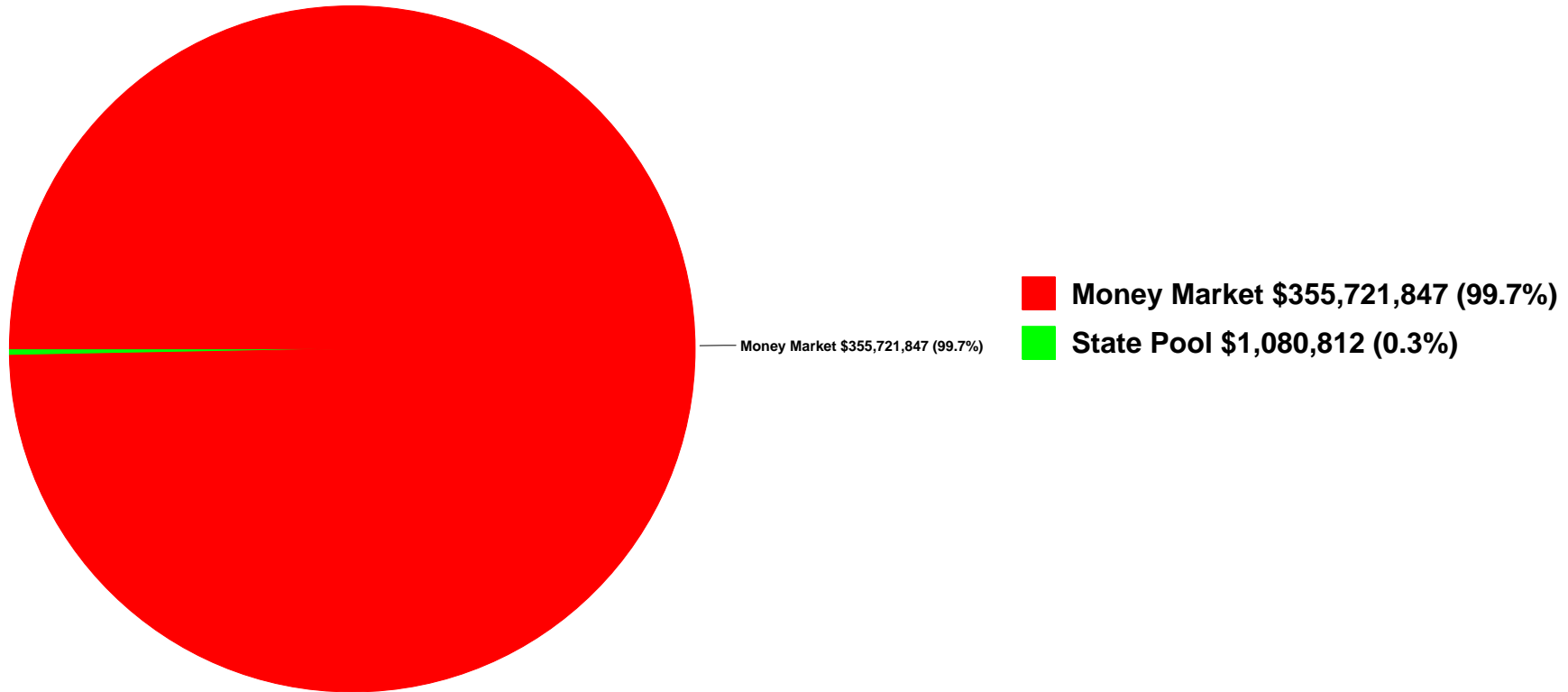

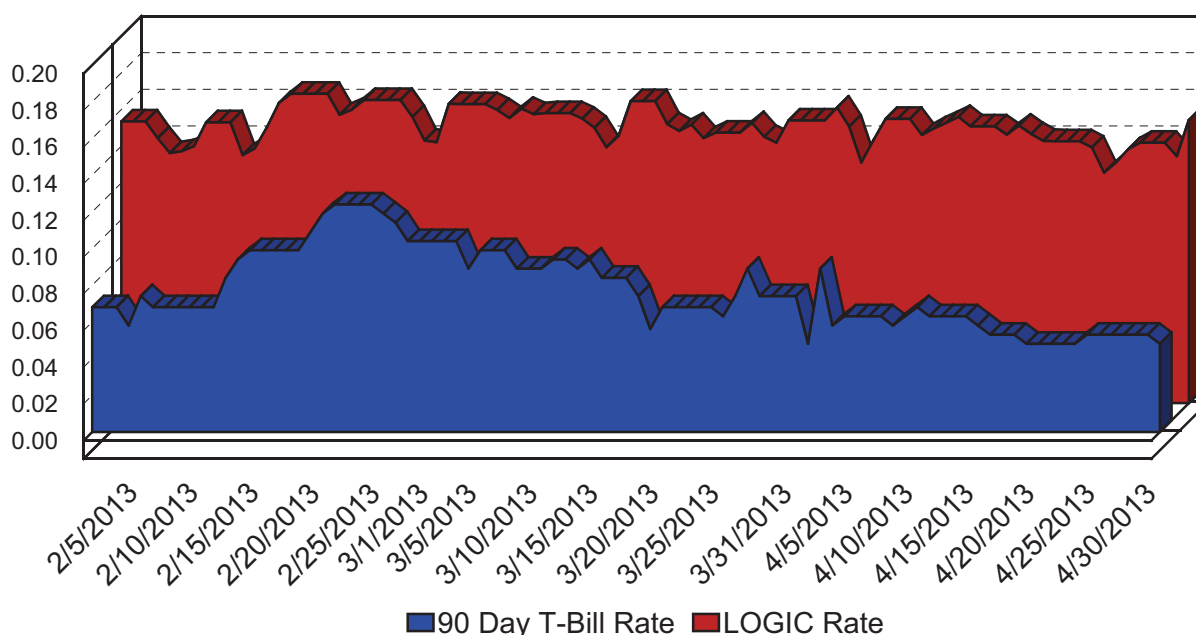
