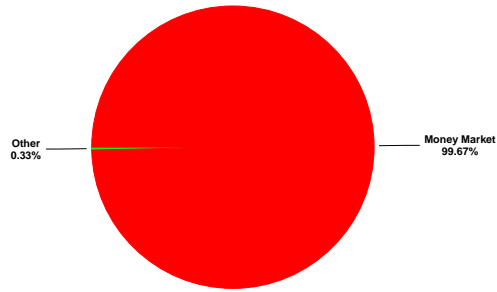

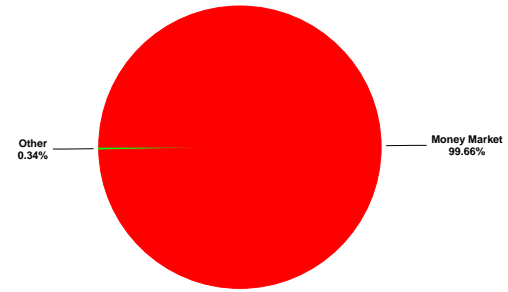

Portfolio Composition - 06/30/13

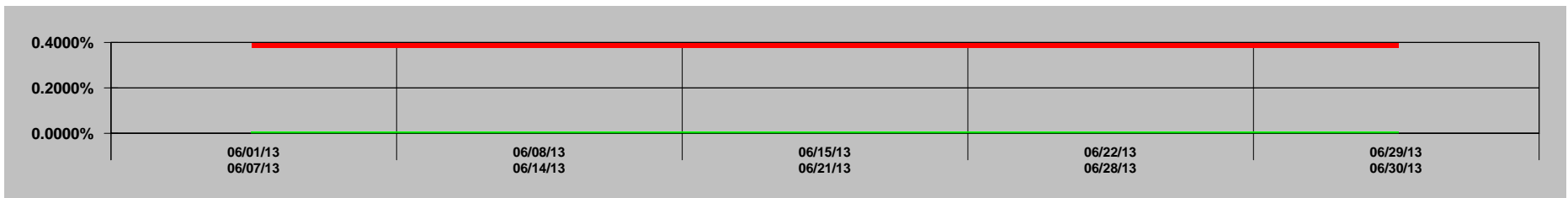


Maturity Aging - 05/31/13 vs 06/30/13

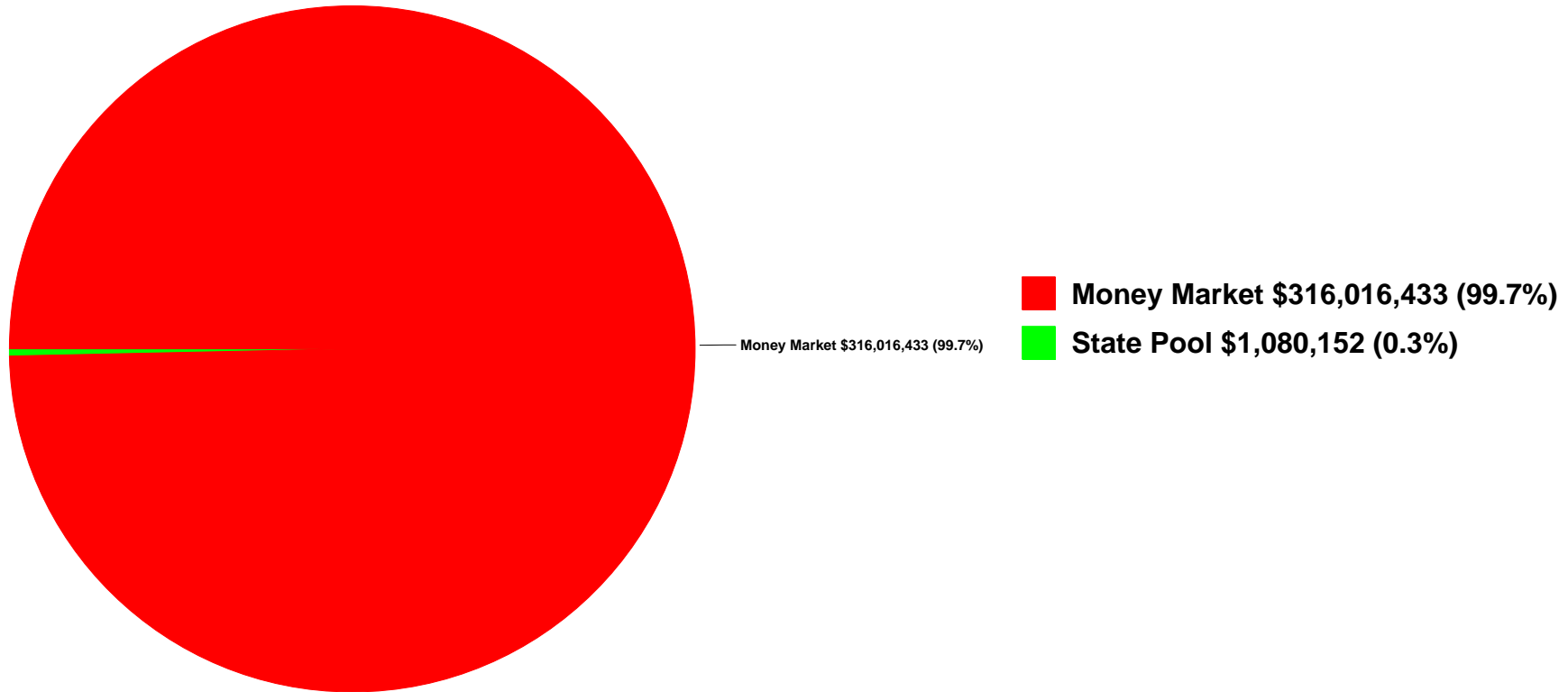

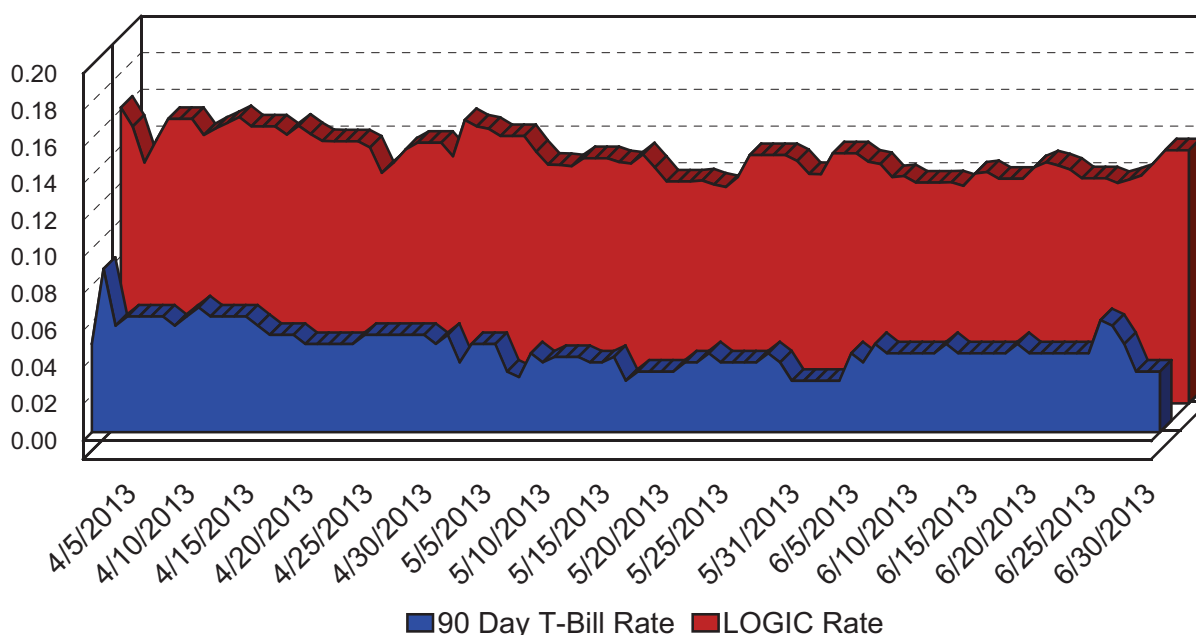
