

## AMENDED AND RESTATED ORDER CALLING DIRECTORS ELECTION

WHEREAS, by order duly adopted by the Board of Directors (the "Board") of Fort Bend County Municipal Utility District No. 35, of Fort Bend County, Texas (the "District") on January 8, 2020 (the "Original Order"), a general election was called for the election of two (2) directors for the District, with such election to be held on May 2, 2020 (the "Election"); and

WHEREAS, the Governor of the State of Texas (the "Governor") issued a proclamation on March 13, 2020, certifying that the outbreak of the contagious respiratory coronavirus designated "COVID-19" poses an imminent threat of disaster and declaring a state of disaster for all counties in Texas under the authority vested in the Governor by Section 418.014 of the Texas Government Code, as amended; and

WHEREAS, the Governor issued a proclamation on March 18, 2020, suspending Sections 41.0052(a) and (b) of the Texas Election Code, as amended, and Section 49.103 of the Texas Water Code, as amended, to the extent necessary to allow political subdivisions that would otherwise hold their general and special elections on May 2, 2020, to postpone such elections to the next uniform election date occurring on November 3, 2020; and

WHEREAS, by order duly adopted by the Board of the District on April 1, 2020, the District postponed the Election until the next uniform election date occurring on November 3, 2020, pursuant to the authority of the Governor's proclamations, in order to prepare for, respond to, and mitigate the spread of COVID-19, protect the health and welfare of the District's voters, election officials, and the general public, and ensure the orderly conduct of the Election; and

WHEREAS, the Board desires that the Election proceed on November 3, 2020, and that this Amended and Restated Order Calling Directors Election (the "Order") amend and restate the Original Order in its entirety.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 35, OF FORT BEND COUNTY, TEXAS, THAT:

Section 1: The Election shall be held on the 3<sup>rd</sup> day of November, 2020 ("Election Day"). At the Election there shall be submitted to the duly qualified resident voters of the District the matter of electing two (2) directors to the Board.

Section 2: All qualified voters of the District shall be entitled to vote in the Election.

Section 3: The District hereby adopts by number, as its precincts for purposes of the Election, those election precincts established by Fort Bend County pursuant to Chapter 42, Texas Election Code, that overlap the District in whole or in part.

Section 4: The District has entered, or will hereafter enter, into a Joint Election Agreement and Contract for Election Services with Fort Bend County, Texas, for election services and for the purpose of conducting a joint election with other participating political subdivisions located, in

whole or in part, in Fort Bend County, Texas, pursuant to Chapter 31 and Chapter 271, Texas Election Code (the "Joint Election Agreement"). The form of the Joint Election Agreement is hereby approved in all respects. The President of the Board is hereby authorized to execute the Joint Election Agreement on behalf of the District. Any prior execution of the Joint Election Agreement by the President of the Board is hereby ratified and approved in all respects.

Section 5: As authorized by Chapter 31 and Chapter 271 of the Texas Election Code, and pursuant to the Joint Election Agreement, the Election shall be conducted by Fort Bend County, Texas. The District hereby appoints John Oldham, Elections Administrator, to perform or to supervise the performance of any and all of the duties and responsibilities related to the conduct of the Election, as further specified in the Joint Election Agreement.

Section 6: As authorized by Chapter 31 and Chapter 271 of the Texas Election Code, and pursuant to the terms of the Joint Election Agreement, the District hereby appoints John Oldham, Elections Administrator, as the Early Voting Clerk for the Election. Early voting by personal appearance for the eligible voters of the District shall be conducted at the locations and on the days and during the times set forth on Exhibit "A" attached hereto. Applications for voting by mail shall be addressed to the Early Voting Clerk. The official mailing address of the Early Voting Clerk is John Oldham, Elections Administrator, Fort Bend County Elections, 301 Jackson Street, Richmond, Texas 77469.

Section 7: Any eligible voter of the District may vote by personal appearance on Election Day, at the polling locations set forth on Exhibit "B" attached hereto. Voting by personal appearance on Election Day shall be conducted between the hours of 7:00 a.m. and 7:00 p.m., except as provided by Sections 41.032 and 41.033, Texas Election Code.

Section 8: Melanie Walsh is hereby appointed as the District's designated election agent (the "Election Agent") to perform election duties required pursuant to the provisions of Section 31.123, Texas Election Code, and Section 49.109, Texas Water Code. The duration of appointment of such Election Agent shall be from the date this Order is passed and adopted by the Board, until a successor is appointed, and the office hours of such Election Agent shall be from 9:00 a.m. to 5:00 p.m. daily, except Saturdays, Sundays or official state holidays. True and correct copies of all documents and materials pertaining to the Election shall be maintained on file in the office of Election Agent at 1300 Post Oak Boulevard, Suite 1400, Houston, Harris County, Texas 77056, open to inspection by the public or any person interested therein.

Section 9: Pursuant to the Original Order, the District previously received written applications to have a person's name printed on the ballot as a candidate for the office of director of the District by the applicable deadline. No person's name shall be placed on the ballot unless he or she: is eighteen (18) years of age or older; is a citizen of the United States; is a resident of the State of Texas; either owns land subject to taxation in the District or is a qualified voter within the District; has not been determined mentally incompetent by a final judgment of a court; has not been convicted of a felony from which he or she has not been pardoned or otherwise released from the resulting disabilities; has filed a loyalty affidavit with the Secretary of the Board or the Election Agent; and is not otherwise disqualified from holding such office. The Secretary of the Board and the Election Agent are authorized to review filings by candidates and determine the qualifications

of candidates for office. Any person not satisfied with said officer's ruling shall be authorized to appeal the decision to the Board.

Section 10: Pursuant to the Original Order, the order in which the names of the candidates are to be printed on the ballot was previously determined by a drawing performed in accordance with the Texas Election Code. The results of such drawing are hereby ratified and approved in all respects.

Section 11: Pursuant to Sections 123.001 and 61.012 of the Texas Election Code, as amended, the District hereby adopts for use at the Election the Election Systems & Software EVS 6020 voting system, for voting or early voting by personal appearance, as same has been certified by the Texas Secretary of State as an accessible direct recording electronic voting system. In addition, pursuant to Sections 123.006, 63.011 and 125.006, Texas Election code, the District authorizes the use of paper ballots to the extent necessary in connection with balloting by mail, provisional balloting, or in the event that an emergency prevents the use of the aforesaid direct recording electronic voting systems.

Ballots shall conform to the requirements of the Texas Election Code and be prepared and made available to voters in the English and Spanish languages.

Ballots shall have printed thereon the names of the candidates for the office of director. A qualified voter may vote for any two (2) or fewer persons for the office of director.

Section 12: This Order shall constitute the order for the calling of the Election and may serve as notice of the Election. The Election Agent is hereby authorized and directed to (i) deliver notice of the Election in English and Spanish to the County Clerk and Voter Registrar of Fort Bend County, Texas not later than sixty (60) days before Election Day, and (ii) cause notice of the Election to be posted in English and Spanish at a public place in each election precinct that is in the jurisdiction of the District, with said posting(s) to be completed not later than twenty-one (21) days before Election Day (unless said day is a Saturday, Sunday or official state holiday and in which case it shall be posted on the next regular business day). Notice of the Election shall also be timely posted on the Internet website of the District, if the District maintains a website, as required by Section 85.007(d)(1) of the Texas Election Code. Further, the Election Agent is hereby authorized and directed, to the extent applicable and if possible, to cause a notice to be posted at the entrance of the polling place for the District's previous election, which notice shall state that the polling location has changed and shall provide the location of the new polling place, all in accordance with applicable law.

Section 13: The Election shall be held and conducted and returns made to this Board in accordance with the laws of the State of Texas, including but not limited to, applicable provisions of the Texas Election Code and the Texas Water Code.

Section 14: The Board officially finds, determines and declares that this Order was reviewed, considered and adopted at a meeting of the Board held on August 5, 2020, via telephone conference call pursuant to Texas Government Code, Section 551.125, as amended, and as modified by the temporary suspension of various provisions thereof effective March 16, 2020, by

the Governor of Texas in accordance with the Texas Disaster Act of 1975, all as related to the Governor's proclamation on March 13, 2020, certifying that the COVID-19 pandemic poses an imminent threat of disaster and declaring a state of disaster for all counties in Texas; and that a sufficient written notice of the time and subject of this meeting, including instructions regarding access and participation in the meeting via telephone conference call, was posted at the District's administrative office and at a place readily accessible and convenient to the public within the District and was timely furnished to the County Clerk of Fort Bend County, Texas, for posting on a bulletin board located at a place convenient to the public in the Fort Bend County Courthouse for the time prescribed by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code, and Section 49.063, Texas Water Code, and that this meeting has been open to the public, as required by law, at all times during which this Order and the subject matter hereof has been discussed, considered and acted upon. The Board further ratifies, approves and confirms such written notice and the contents and posting thereof.


Section 15: This Order shall supersede and replace the Original Order, which is hereby revoked in its entirety. The Board hereby reserves the right to amend or supplement this Order as deemed necessary and appropriate. The Board further reserves the right to cancel the Election if and as allowed in accordance with the provisions of Chapter 2, Subchapter C, Texas Election Code.

Section 16: Unless expressly provided otherwise, all references herein to the Texas Election Code or to the Texas Water Code shall mean and refer to such laws as amended and in effect as of the date this Order is passed and adopted.


Section 17: The President or Vice President and Secretary or Assistant Secretary of the Board and the Election Agent are each hereby authorized and directed to take any action necessary to carry out the provisions of this Order. Further, the Election Agent, with the consent of the President of the Board, shall be authorized to correct Exhibit "A" and Exhibit "B" attached hereto to reflect any changes by Fort Bend County to the early voting and Election Day polling information set forth thereon, without need for amendment of this Order by the Board.

EN VISTA DE QUE, por orden debidamente adoptada por la Junta Directiva (la "Junta") del Fort Bend County Municipal Utility District No. 35, of Fort Bend County, Texas (el "Distrito") el 8 de enero de 2020 (la "Orden Original") se convocó una elección general para elegir a dos (2) directores para el Distrito con la celebración de dicha elección el 2 de mayo de 2020 (la "Elección"); y

EN VISTA DE QUE el 18 de marzo de 2020 el Gobernador emitió una proclamación para suspender las Secciones 41.0052(a) y (b) del Código Electoral de Texas y sus enmiendas, y la Sección 49.103 del Código de Agua de Texas y sus enmiendas en la medida necesaria para permitir a las subdivisiones políticas que de otra manera celebrarían sus elecciones generales y especiales el 2 de mayo de 2020, postergar dichas elecciones a la siguiente fecha de elección uniforme que es el 3 de noviembre de 2020; y

EN VISTA DE QUE, por orden debidamente adoptada por la Junta del Distrito el 1 de abril de 2020, el Distrito postergó la Elección hasta la siguiente fecha de elección uniforme, que es el 3 de noviembre de 2020, en virtud de la autoridad de las proclamaciones del Gobernador, con el fin de prepararse, responder y mitigar la propagación del COVID-19, proteger la salud y el bienestar de los votantes del Distrito, funcionarios electorales y el público general, y asegurar la celebración ordenada de la Elección; y

EN VISTA DE QUE la Junta desea que la Elección proceda el 3 de noviembre de 2020 y que esta Orden enmendada y reformulada para convocar una elección de directores (la "Orden") modifique y reformule la Orden Original en su totalidad.

AHORA, POR LO TANTO, LA JUNTA DIRECTIVA DEL FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 35, DEL CONDADO DE FORT BEND, TEXAS, ORDENA QUE:

Sección 1: La Elección se celebrará el 3 de noviembre de 2020 ("Día de Elección"). En la Elección se presentará a los votantes debidamente habilitados residentes del Distrito el asunto de elegir dos (2) directores para la Junta.

Sección 2: Todos los votantes habilitados del Distrito tendrán derecho de votar en la Elección.

Por la presente, se autoriza al Presidente de la Junta a firmar el Convenio de Elecciones Conjuntas en nombre del Distrito. Por la presente, se ratifica y aprueba a todo efecto toda firma previa del Convenio de Elecciones Conjuntas por parte del Presidente de la Junta.

Sección 5: Como lo autorizan el Capítulo 31 y el Capítulo 271 del Código Electoral de Texas, y en virtud del Convenio de Elecciones Conjuntas, la Elección será celebrada por el Condado de Fort Bend, Texas. Por la presente el Distrito designa a John Oldham, Elections Administrator, para realizar o supervisar el cumplimiento con todas y cada una de las obligaciones y responsabilidades relacionadas con la celebración de la Elección según se especifique adicionalmente en el Convenio de Elecciones Conjuntas.

Sección 6: Como lo autorizan el Capítulo 31 y el Capítulo 271 del Código Electoral de Texas, y en virtud de los términos del Convenio de Elecciones Conjuntas, por la presente el Distrito designa a John Oldham, Elections Administrator, como el/la Oficial de Votación Anticipada de la Elección. La votación anticipada en persona para los votantes elegibles del Distrito se llevará a cabo en los lugares y en los días y durante los horarios indicados en el Anexo “A” adjunto a la presente. Las solicitudes para votar por correo deberán dirigirse al Oficial de Votación Anticipada. La dirección postal oficial del Oficial de Votación Anticipada es: John Oldham, Elections Administrator, Fort Bend County Elections, 301 Jackson Street, Richmond, Texas 77469.

Sección 7: Todo votante habilitado del Distrito puede votar en persona el Día de Elección en los lugares de votación indicados en el Anexo “B” adjunto a la presente. La votación en persona el Día de Elección se llevará a cabo en el horario de 7:00 a.m. a 7:00 p.m., salvo lo dispuesto por las Secciones 41.032 y 41.033 del Código Electoral de Texas.

Sección 8: Por la presente se designa a Melanie Walsh como agente electoral del Distrito (el “Agente Electoral”) para llevar a cabo las funciones electorales requeridas en virtud de las disposiciones de la Sección 31.123 del Código Electoral de Texas y de la Sección 49.109 del Código de Agua de Texas. La duración de la designación de dicho Agente Electoral se extenderá desde la fecha de aprobación y adopción de la Junta de esta Orden hasta que se designe a un sucesor, y el horario de atención de dicho Agente Electoral será todos los días de 9:00 a.m. a 5:00 p.m., salvo sábados, domingos o feriados oficiales del estado. No se colocará el nombre de ninguna persona en la boleta de votación a menos que: tenga dieciocho (18) años de edad o más; sea ciudadano de Estados Unidos; sea residente del Estado de Texas; sea propietario de terreno sujeto a impuestos en el Distrito o sea un votante habilitado dentro del Distrito; no haya sido declarado mentalmente incompetente por el fallo de un tribunal; no haya sido condenado por un delito mayor del cual él o ella no haya sido indultado o librado de alguna otra forma de las discapacidades resultantes; haya presentado una declaración jurada de lealtad ante el Secretario de la Junta o ante el Agente Electoral; y no esté inhabilitado de alguna otra forma para ocupar dicho cargo. El Secretario de la Junta y el Agente Electoral están autorizados a revisar las postulaciones de los candidatos y a determinar los requisitos de los candidatos para ocupar el cargo. Toda persona que no esté conforme con la determinación de dicho funcionario estará autorizada a apelar la decisión ante la Junta.

Sección 11: En virtud de las Secciones 123.001 y 61.012 del Código Electoral de Texas y sus enmiendas, por la presente el Distrito adopta para uso en la Elección el Election Systems & Software EVS 6020 voting system, para la votación o votación anticipada en persona, ya que el mismo ha sido certificado por la Secretaría de Estado de Texas como un sistema de votación electrónica de registro directo de fácil acceso. Además, en virtud de las Secciones 123.006, 63.011 y 125.006 del Código Electoral de Texas, el Distrito autoriza el uso de boletas de votación de papel en la medida necesaria en relación con la votación por correo, para los votos provisionales, o en el caso de que una emergencia impida el uso de los mencionados sistemas de votación electrónica de registro directo.

Las boletas de votación cumplirán con los requisitos del Código Electoral de Texas y se prepararán y estarán disponibles para los votantes en los idiomas inglés y español.

Sección 14: La Junta oficialmente halla, determina y declara que esta Orden fue revisada, considerada y adoptada en una asamblea de la Junta que se realizó el 5 de agosto de 2020, por llamado en conferencia telefónica en virtud de la Sección 551.125 del Código de Gobierno de Texas y sus enmiendas, y según lo modificado por la suspensión provisoria de diversas disposiciones del mismo vigentes desde el 16 de marzo de 2020 por el Gobernador de Texas en conformidad con la Ley de desastres de Texas de 1975, todo relacionado con la proclamación del Gobernador del 13 de marzo de 2020 que certificada que la pandemia del COVID-19 plantea una amenaza inminente de desastre y declaraba un estado de desastre para todos los condados de Texas; y que se colocó un aviso escrito suficiente del horario y el asunto de esta asamblea, incluso instrucciones para el acceso y la participación en la asamblea mediante llamado por conferencia telefónica, en la oficina administrativa del Distrito y en un lugar de fácil acceso y cómodo para el público dentro del Distrito y que fue entregado oportunamente al Secretario del Condado del Condado de Fort Bend, Texas, para colocación en un tablero de anuncios ubicado en un lugar cómodo para el público en el Tribunal del Condado de Fort Bend por el periodo prescrito por ley precedente a esta asamblea, como lo requiere la Ley de Asambleas Públicas, Capítulo 551 del Código de Gobierno de Texas y la Sección 49.063 del Código de Agua de Texas, y que esta asamblea ha estado abierta al público, como lo exige la ley, en todo momento durante el cual se ha debatido, considerado y actuado en relación a esta Orden y el asunto de la misma. La Junta además ratifica, aprueba y confirma dicho aviso escrito y su contenido y colocación.

Sección 15: Esta Orden sustituirá y reemplazará a la Orden Original, que por la presente queda revocada en su totalidad. Por la presente la Junta se reserva el derecho de modificar o complementar esta Orden según sea necesario y adecuado. La Junta además se reserva el derecho de cancelar la Elección si lo permiten las disposiciones del Subcapítulo C del Capítulo 2 del Código Electoral de Texas y en conformidad con las mismas.

Sección 16: A menos que sea dispuesto expresamente de otra manera, toda referencia hecha en el presente al Código Electoral de Texas o al Código de Agua de Texas significa y se refiere a tales leyes como han sido enmendadas y como están vigentes a la fecha de aprobación y adopción esta Orden.

Sección 17: Por la presente, se autoriza e instruye al Presidente o Vicepresidente y al Secretario o Secretario Asistente de la Junta y al Agente Electoral a tomar cualquier medida

necesaria para implementar las disposiciones de esta Orden. Además, el Agente Electoral, con el consentimiento del Presidente de la Junta, estará autorizado para corregir el Anexo "A" y el Anexo "B", adjuntos a la presente, para reflejar cualquier cambio implementado por el Condado de Fort Bend a la información de votación de la votación anticipada y del Día de Elección indicada en ellos, sin la necesidad de que la Junta tenga que enmendar esta Orden.
